June 12 & 13

Eligibility: Any duly registered owner/skipper of an Santa Barbara Class boat who is a member of the AMYA, or his/her appropriate national authority, may participate in this regatta.

Entry: Any eligible owner/skipper may enter the regatta by completing and returning the Entry Form, together with a check, in the amount of \$30.00 payable to the Chicago R/C Model Yacht Club, c/o Bob Armbruster, 7 Court of Hidden Bay, Northbrook, IL 60062. The Entry Form must be Postmarked no later than June 2, 2010. To be eligible for frequency assignment, the Entry Form **MUST** indicate at least three (3) available frequencies for each boat entered or indicate a 2.4GHz radio.

Prizes: Trophies and Red Chevrons will be awarded to the top three (3) finishers in the regatta.

Measurement: Measurement of the boats and sails will be conducted on a random basis, as determined by the Regatta Director.

Schedule of Events: Registration and weigh in will be at the Race Site on Friday and Saturday, June 12 & 13, 2010. (Please try to register and weigh in on Friday, as Saturday morning will be busy) The lake will be available for practice racing Friday after 12:00 noon. The regatta will begin on Saturday, June 12 and continue through Sunday, June 13. Racing will begin each day at 10:00 AM following a 9:30 AM skippers' meeting with the last race beginning not later than 4: PM on Saturday and 2:00 PM on Sunday. Trophies will be presented following the conclusion of racing on Sunday.

Lunch will be provided each day as well as liquid refreshments through out the day

Sailing Instructions & Frequency Assignments: A copy of the Sailing Instructions, frequency assignments, and schedule will be posted on our web site, after the close of entries.

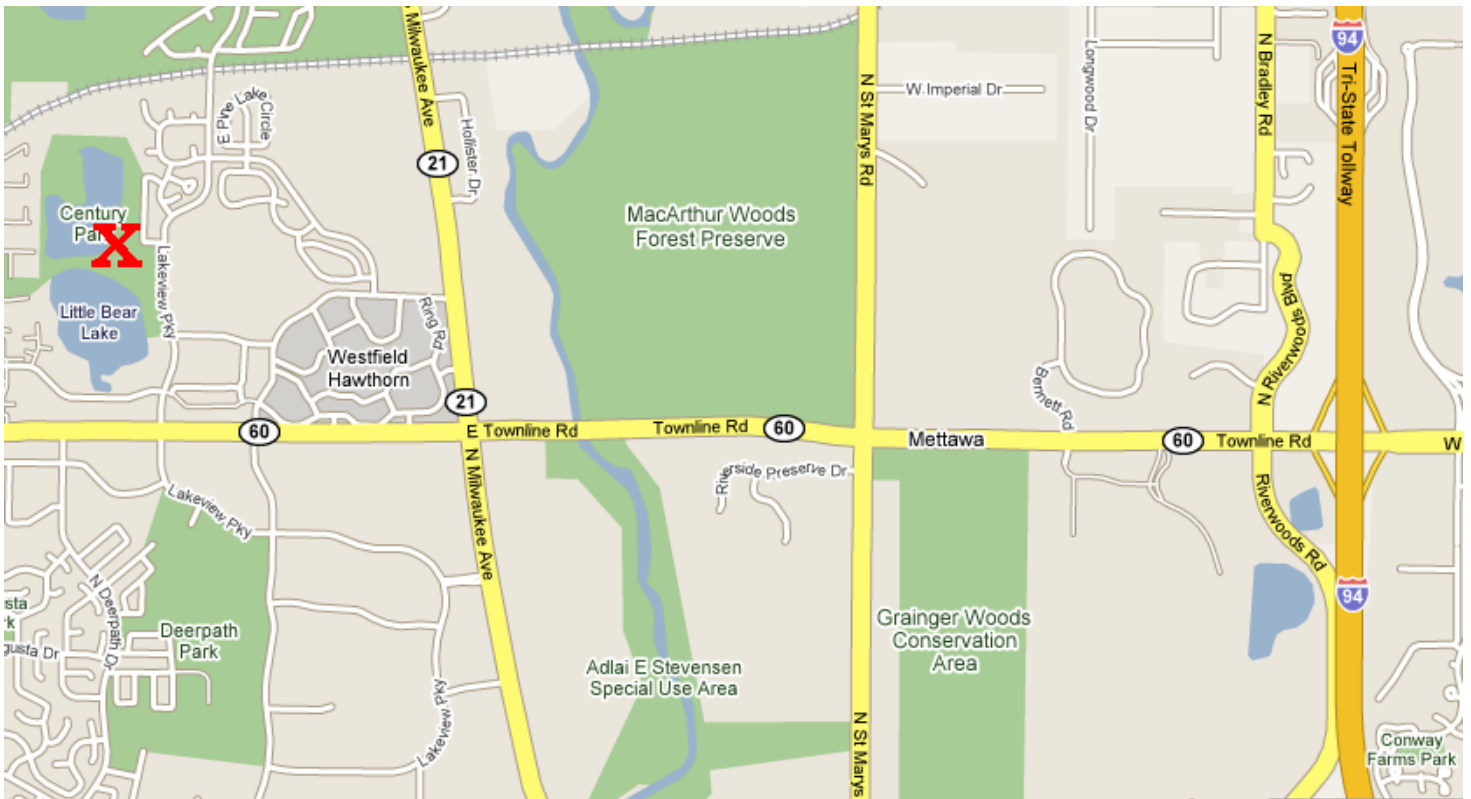
Sailing & Scoring: If in the opinion of the Race Director the number of entries is large enough that it is not equitable for all entries to sail in a single heat race the fleet will be divided as determined on race day.

Scoring will be the usual low score system of 1 point for 1st, 2 points for 2nd, 3 points for 3rd, etc.
