

**NOTICE OF RACE**  
**Santa Barbara**  
**2009 Region 4 Championship Regatta**

**June 13 &14, 2009**

**Eligibility:** Any duly registered owner/skipper of a Santa Barbara Class boat, who is a member of the AMYA, or his/her appropriate national authority, may participate in this regatta.

**Entry:** Any eligible owner/skipper may enter the regatta by completing and returning the Entry Form, together with a check, in the amount of \$35.00 payable to the Chicago R/C Model Yacht Club % Tom Lenhart, 927 Sumac Ct., Lindenhurst, IL 60046. The Entry Form must be postmarked no later than May 30, 2009. To be eligible for frequency assignment, the Entry Form **MUST** indicate at least three (3) available frequencies for each boat entered.

**Prizes:** Trophies and Red Chevrons will be awarded to the top three (3) finishers in the regatta.

**Measurement:** All boats will be weighed and the Regatta Director and his assistants will verify compliance with class rules.

**Schedule of Events:** Registration will be at the Race Site on Friday and Saturday, June 12 & 13, 2009. The lake will be available for practice racing Friday after 12:00 noon. The regatta will begin on Saturday, June 13 and continue through Sunday, June 14. Racing will begin each day following a 9:00 AM skippers' meeting with the last race beginning not later than 4: PM on Saturday and 2:00 PM on Sunday. Trophies will be presented following the conclusion of racing on Sunday.

Lunch will be provided each day as well as liquid refreshments through out the day. Cocktails and a group dinner will be organized for Saturday evening, June 13.

**Sailing Instructions & Frequency Assignments:** A copy of the Sailing Instructions, frequency assignments, and schedule will be emailed or posted to all entrants, after the close of entries.

**Sailing & Scoring:** Races will be sailed according to the ISAF Rules of Racing as modified by Appendix E and the Santa Barbara Class Rules. Scoring will be the usual low score system of 1 point for 1<sup>st</sup>, 2 points for 2<sup>nd</sup>, 3 points for 3<sup>rd</sup>, etc.

If in the opinion of the Race Director the number of entries is large enough that it is not equitable for all entries to sail in a single heat race then a promotion/relegation system will be used for the regatta. There will be no appeal of a protest committee decision if that appeal could affect any boat's promotion or relegation.

**Regatta Site:** The regatta site will be at Big Bear Lake in Century Park, Vernon Hills IL.
